

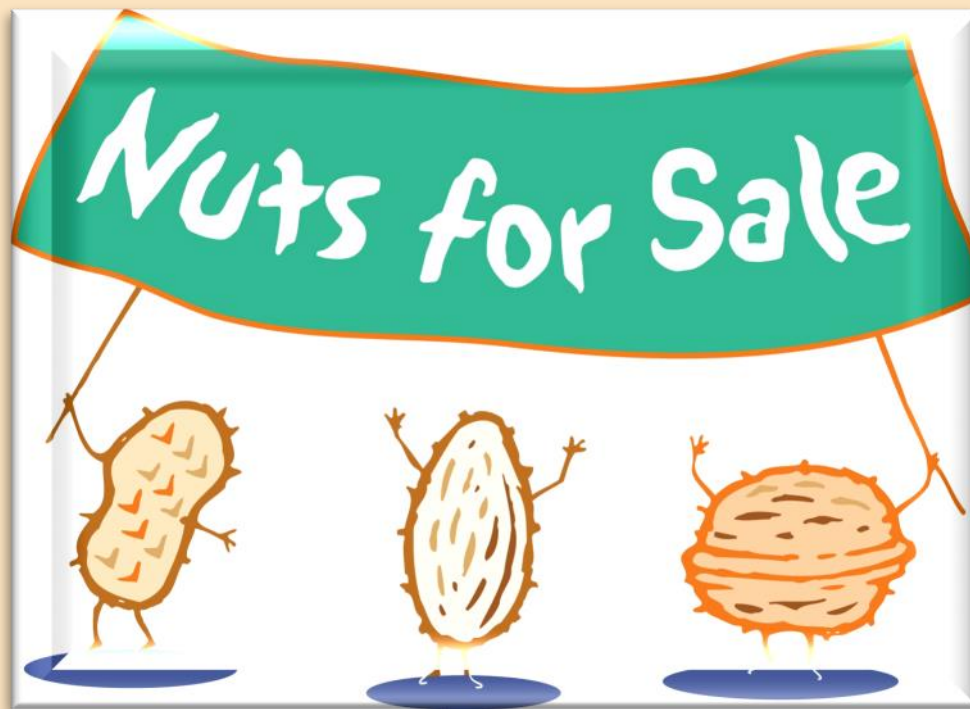

In the past, we have always taken individual orders and because the company requires us to order full cases, we’ve always sold the “extras or leftovers” after the order was delivered. This year, not having church activities, etc., it will be very difficult to sell all the extras we have to purchase. We had first thought that we would not place an order this year, but we have had requests for pecans. Therefore, we are offering some of the products that have been the biggest sellers in the past, but we **will only take orders for FULL CASES**. Each case has 12 one pound bags.
